- ELIGIBILITY:** RMSPGA Class A (1, 2, 4-24), Master Professional, Life Member Active, Life Member Master Professional Active members and those who are otherwise eligible as prescribed by the eligibility rules set forth by the PGA of America and the RMSPGA Tournament Rules & Regulations.
- FORMAT:** 36-hole stroke play. Top finishers will advance to the 53rd (2020) PGA Professional Championship. Number of players advancing to the PGA PC is 4 (four) with 4 (four) alternates identified. Play will be governed by the Rules of Golf. Questions shall be settled by the designated Rules Committee whose decision shall be final. There will NOT be a separate Senior Division for this event. Those contestants age 50 or over as of Tuesday, August 27, will be eligible for a Senior bonus purse. All male contestants will play from the same set of tees. Women should consult the entry information from the PGA of America regarding tees.
- PURSE:** **\$30,000 anticipated based on a 50 player field.**
- PRACTICE:** Monday, August 26, is the official practice round. Please call early to arrange a practice round. Practice times are on availability basis. An optional skins game will be offered during the practice round.
- ENTRY FEE:** **\$225 – Contestants must enter this event through the PGA of America via on-line registration at www.pga.org or www.pgatournaments.com or by calling 1-800-474-2776.** When registering by phone, please ask for a confirmation number when entering the event, as this will be your only record of entry. If you're registering online, print the confirmation page at the end of the registration process, as this will be your only proof of entry. Please refer to the entry and eligibility information document supplied by the PGA of America regarding withdrawals. Entry fees will not be refunded after the August 21st entry deadline, unless for extreme circumstances such as hospitalization or personal bereavement. A \$25 administration fee will be held for any withdrawal.
- ENTRIES CLOSE:** **Entries are being accepted through the PGA of America and conclude Wednesday, August 21st, at 4:00 p.m. MDT. Late entries will not be accepted.**
- STARTING TIME:** First round starting times will be available by Friday, August 23rd by 1:00 p.m. on the Championship page within BlueGolf.
- CLUBS:** The PGA of America adopted the conditions of competition for grooves and/or punch marks at the Section level (qualifying stages) of this event. All players must comply with this condition of competition.
