- HOST:** Zach Jonas, PGA – (208) 788-5400
- ELIGIBILITY:** SRC Members and Associates who have paid the 2024 Player Fee and are otherwise eligible.
- FORMAT:** **MATCH PLAY** - *The top 16 players in Regular & Senior divisions will advance to The Valley Club to complete the Match Play brackets. Depending on the number of entries, qualifying matches will be played at-large prior to October 1<sup>st</sup>, 2024, at a location agreed upon by the players.* The round of 16 matches will be played the morning of day 1 and quarter-final matches will be played in the afternoon. All round of 16 losing players will be moved to a consolation bracket. All semi-final and final matches will be played on day 2. All seeding will be done by the final June 30<sup>th</sup>, 2024 Carter Cup points list. Players with no points will be blind drawn, Members first followed by Associates.
- NOTE:** In the event of a player not being able to advance to The Valley Club after winning an “at-large” match, the losing player advances. Should the losing player not be able to play, the highest seeded “at-large” loser will then advance. Should a player with an “at-large” bye not be able to make it to The Valley Club, again, the highest seeded “at-large” loser will advance.
- PURSE:** \$8,000 total purse anticipated based on 48 entries.
- ENTRY FEE:** \$60 to enter and an additional \$150 should you advance to the Host Site. By paying the initial \$60 entry, you agree to pay the additional \$150 should you advance whether you play or not. Entry includes the following at the Host Site: lunch after the first round, range, and golf car. Expenses at “at-large” sites not included.
- ENTRIES CLOSE:** **Deadline for entry applications is 4:00 p.m. MDT on Wednesday, July 31, 2024.** All contestants are to enter via Blue Golf at [www.rockymountainpga.com](http://www.rockymountainpga.com). All entries must be received by the stated deadline.
- STARTING TIMES:** TBD (weather permitting). Afternoon matches will begin as time allows. All second day play will be tee times beginning at 9:00 a.m. (weather permitting).
- PRACTICE** Contestants are to call The Valley Club at the number listed above to schedule practice rounds.
- LODGING:** Check local listings for various lodging options.
